This irrevocable authority shall not be capable of revocation without the written consent of CIMB Islamic addressed to you and unless so revoked, shall be binding on my/our estate, heirs, personal representatives, permitted assigns and/or successors in title as the case may be.

I/We confirm that you are to be under no obligation to ascertain or to inquire into the purpose for which any of the above powers is exercised.
