and

(2) **CIMB ISLAMIC BANK BERHAD** (Company No. 200401032872 (671380-H)), a licensed bank incorporated in Malaysia and having its registered office at Level 13, Menara CIMB, Jalan Stesen Sentral 2, Kuala Lumpur Sentral, 50470 Kuala Lumpur (hereinafter referred to as the "**Bank**") and through such branch as identified in the Letter of Offer (as set out in **Item 3 of Schedule 1**).

NOW IT IS HEREBY AGREED as follows:

#### 1. DEFINITIONS AND INTERPRETATION
