

**FAQ – Update on SecureTAC Requirement for Own Account Transfers - CIMB Online Banking
- 12 June 2026**

**1. Question: When transferring between my own CIMB accounts, which accounts
require SecureTAC approval for fund transfers?**

Answer: Starting 12 June 2026, when transferring between own CIMB accounts, SecureTAC approval will require for transfers of RM1,000 and above.
