**Important Notice: Revision to the CIMB Preferred Visa Infinite and CIMB Preferred Visa Infinite-i Credit Card 1-For-1 Dining Terms & Conditions**

Dear Valued Cardholders,

We hereby give twenty-one (21) calendar days' notice that effective 1 October 2023, the CIMB Preferred Visa Infinite and CIMB Preferred Visa Infinite-i Credit Card 1-For-1 Dining Terms and Conditions will be revised. The revision will also allow CIMB Visa Infinite and CIMB PETRONAS Visa Infinite-i Credit Card to be included in this promotion, and the promotion mechanics have been revised as follows:

For additional complimentary set menus, Group 1 cardholders are required to meet the monthly spend requirement set out in Table A below.</p> <p>(b) CIMB Preferred Visa Infinite and CIMB Preferred Visa Infinite-i credit cardholders who do not meet the AUM minimum balance requirement of RM250,000 (Group 2) are required to meet the monthly spend requirement stated in Table A to enjoy complimentary set menu at any participating restaurant.</p> <p>(c) CIMB Visa Infinite and CIMB PETRONAS Visa Infinite-i cardholders (Group 2) are required to meet the monthly spend requirement stated in Table A to enjoy complimentary set menu at any participating restaurant. For instance, a CIMB Preferred client with AUM <math>\geq</math> RM250,000 who holds a CIMB Visa Infinite credit card is still required to meet the monthly spend requirement of RM5,000 to be eligible for one complimentary set menu in a calendar month at any participating restaurant.</p> <p>(d) The monthly spend requirement must be met in the same calendar month at the point of reservation, i.e. payment date for the set menu. The monthly spend requirement must also be met on the same Eligible Card that is used by the cardholder for the complimentary set menu. If both requirements are not met, the cost of the complimentary menu enjoyed by the cardholder would be charged to the same Eligible Card account. For eg. if the Eligible Cardholder called to make a reservation in October 2023 for a visit to the participating restaurant in December 2023 on a supplementary Eligible Card, the monthly spend requirement must be met on the same supplementary Eligible Card in October 2023 (and not December 2023).</p>

\*Monthly spend requirement includes both local and overseas transactions but excludes Balance Transfer, Cashlite, Balance Conversion, Flexi Payment Plan or any monthly instalments under any instalment payment facility provided by CIMB, Cash Advance/withdrawal/deposit transactions, interest charges/management fee and/or any other credit card/-i related fees and charges, or other transactions which are subsequently cancelled or refunded, disputed, unauthorized or fraudulent transactions.

(e) For illustration purposes, an Eligible Cardholder from Group 1 calls for a reservation in October 2023 who wants to enjoy 2 complimentary set menus in November 2023. The cardholder would be required to spend a minimum of RM7,500 in October 2023. If the cardholder only spends RM5,000 in October 2023, he/she will be charged with the cost of the second set menu based on latest payment transaction date and time at the point of reservation.

(f) If an Eligible Cardholder from Group 2 calls for reservations in October 2023 who wants to enjoy 3 complimentary set menus in October, November and December 2023 (1 complimentary set menu per month) but the reservations were not made in chronological order but for October, December and finally November 2023. The cardholder would be required to spend a minimum of RM10,000 in October 2023. If the cardholder only spends RM8,000 in October 2023, he/she will be charged with the cost of the third set menu based on payment transaction date and time, i.e. for the November set menu.
