Please be informed of the revised Terms and Conditions for CIMB Petronas Platinum Credit Card, CIMB Petronas Platinum-i Credit Card (“**CIMB Petronas Credit Card**”) and CIMB Cash Rebate Credit Card.

The effective date of the revised Terms and Conditions is 15 September 2020.

The revised Terms and Conditions for CIMB Petronas Credit Cards are as below:-
