

Frequently Asked Questions (FAQ) – Revision of Cash Rebates and Bonus Points for CIMB Merchant Credit Card

(A) CIMB Allianz Merchant Credit Card

- 1. When will the revision of Cash Rebates / Bonus Points for Allianz spend at CIMB Bank credit card terminals using CIMB Allianz Merchant Credit Card be effective?**

You will receive the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point for transactions posted on 1 April 2025 onwards. Please see the following example scenarios:

Scenario A:

You performed an Allianz transaction of RM1,000 at CIMB Terminals using your CIMB Allianz Merchant Credit Card on 25 March 2025, and the transaction is reflected in your statement on 27 March 2025. This transaction will still be eligible for the existing 0.8% Cash Rebate / RM1 = 2 Bonus Point.

Scenario B:

You performed an Allianz transaction of RM1,000 at CIMB Terminals using your CIMB Allianz Merchant Credit Card on 31 March 2025, and the transaction is reflected in your statement on 2 April 2025. This transaction is only eligible for the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point.

- 2. Will I still receive Cash Rebate / Bonus Point on other transactions (for example groceries or dining spend) made using my CIMB Allianz Merchant Credit Card?**

There are no revisions to the Cash Rebate / Bonus Point awarded on other transactions made using CIMB Allianz Merchant Credit Card. Other transactions are defined as any non-Allianz spend at CIMB Terminals and/or any transactions at non-CIMB Terminals.

(B) CIMB Penang Swimming Club Merchant Credit Card

- 1. When will the revision of Bonus Points for Penang Swimming Club spend at CIMB Bank credit card terminals using CIMB Penang Swimming Club Merchant Credit Card be effective?**

You will receive the revised RM1 = 1 Bonus Point reward for transactions posted on 1 April 2025 onwards. Please see the following example scenarios:

Scenario A:

You performed a Penang Swimming Club transaction of RM1,000 at CIMB Terminals using your CIMB Penang Swimming Club Merchant Credit Card on 25 March 2025, and the transaction is reflected in your statement on 27 March 2025. This transaction will still be eligible for the existing RM1 = 2 Bonus Points.

Scenario B:

You performed a Penang Swimming Club transaction of RM1,000 at CIMB Terminals using your CIMB Penang Swimming Club Merchant Credit Card on 31 March 2025, and the transaction is reflected in your statement on 2 April 2025. This transaction is only eligible for the revised RM1 = 1 Bonus Point.

2. Will I still receive Bonus Point on other transactions (for example groceries or dining spend) made using my CIMB Penang Swimming Club Merchant Credit Card?

There are no revisions to the Bonus Point awarded on other transactions made using CIMB Penang Swimming Club Merchant Credit Card. Other transactions are defined as any non-Penang Swimming Club spend at CIMB Terminals and/or any transactions at non-CIMB Terminals.

(C) CIMB Everpro Merchant Credit Card

1. When will the revision of Cash Rebate / Bonus Point for Everpro spend at CIMB Bank credit card terminals using CIMB Everpro Merchant Credit Card be effective?

You will receive the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point reward for transactions posted on 1 April 2025 onwards. Please see the following example scenarios:

Scenario A:

You performed an Everpro transaction of RM1,000 at CIMB Terminals using your CIMB Everpro Merchant Credit Card on 25 March 2025, and the transaction is reflected in your statement on 27 March 2025. This transaction will still be eligible for the existing 1% Cash Rebate / RM1 = 2 Bonus Points.

Scenario B:

You performed an Everpro transaction of RM1,000 at CIMB Terminals using your CIMB Everpro Merchant Credit Card on 31 March 2025, and the transaction is reflected in your statement on 2 April 2025. This transaction is only eligible for the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point.

2. Will I still receive Cash Rebate / Bonus Point on other transactions (for example groceries or dining spend) made using my CIMB Everpro Merchant Credit Card?

There are no revisions to the Cash Rebate / Bonus Point awarded on other transactions made using CIMB Everpro Merchant Credit Card. Other transactions are defined as any non-Everpro spend at CIMB Terminals and/or any transactions at non-CIMB Terminals.

(D) CIMB Nature Environment Products Merchant Credit Card

1. When will the revision of Cash Rebate / Bonus Point for Nature Environment Products spend at CIMB Bank credit card terminals using CIMB Nature Environment Products Merchant Credit Card be effective?

You will receive the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point reward for transactions posted on 1 April 2025 onwards. Please see the following example scenarios:

Scenario A:

You performed a Nature Environment Products transaction of RM1,000 at CIMB Terminals using your CIMB Nature Environment Products Merchant Credit Card on 25 March 2025, and the transaction is reflected in your statement on 27 March 2025. This transaction will still be eligible for the existing 1% Cash Rebate / RM1 = 2 Bonus Points.

Scenario B:

You performed a Nature Environment Products transaction of RM1,000 at CIMB Terminals using your CIMB Nature Environment Products Merchant Credit Card on 31 March 2025, and the transaction is reflected in your statement on 2 April 2025. This transaction is only eligible for the revised 0.2% Cash Rebate / RM1 = 1 Bonus Point.

2. Will I still receive Cash Rebate / Bonus Point on other transactions (for example groceries or dining spend) made using my CIMB Nature Environment Products Merchant Credit Card?

There are no revisions to the Cash Rebate / Bonus Point awarded on other transactions made using CIMB Nature Environment Products Merchant Credit Card. Other transactions are defined as any non-Nature Environment Products spend at CIMB Terminals and/or any transactions at non-CIMB Terminals.

(E) CIMB Crony Beauty Merchant Credit Card

1. When will the revision of Bonus Point for Crony Beauty spend at CIMB Bank credit card terminals using CIMB Crony Beauty Merchant Credit Card be effective?

You will receive the revised RM1 = 1 Bonus Point reward for transactions posted on 1 April 2025 onwards. Please see the following example scenarios:

Scenario A:

You performed a Crony Beauty transaction of RM1,000 at CIMB Terminals using your CIMB Crony Beauty Merchant Credit Card on 25 March 2025, and the transaction is reflected in your statement on 27 March 2025. This transaction will still be eligible for the existing RM1 = 2 Bonus Points.

Scenario B:

You performed a Crony Beauty transaction of RM1,000 at CIMB Terminals using your CIMB Crony Beauty Merchant Credit Card on 31 March 2025, and the transaction is reflected in your statement on 2 April 2025. This transaction is only eligible for the revised RM1 = 1 Bonus Point.

2. Will I still receive Bonus Point on other transactions (for example groceries or dining spend) made using my CIMB Crony Beauty Merchant Credit Card?

There are no revisions to the Bonus Point awarded on other transactions made using CIMB Crony Beauty Merchant Credit Card. Other transactions are defined as any non-Crony Beauty spend at CIMB Terminals and/or any transactions at non-CIMB Terminals.
